The undersigned, being fully aware that participation in the rodeo will expose him or her to substantial and serious risk of property damage and/or personal injury or death hereby releases FJR Committee from liability for any and all property damage, personal injuries or other claims arising from undersigned participation in the FJR including those that are known and unknown, foreseen and unforeseen, future or contingent.
